#### Message from F&B Manawatū Chair

The main event of the month has been me attending the F&B National AGM and Council meeting as the Branch Councillor. This was a 4-hour event on Zoom. It was a very good opportunity to get a handle on what our national office has going on. And there is a lot. Chief Executive Nicola Toki is impressive with her drive, enthusiasm and fearlessness. For the first time in 101years, F&B has a woman President, Kate Graeme. The other women voted on to the board,I believe, are very well suited to the role, according to the 2-minute bios they gave about themselves.

Our urban rat trap plans for our membership are coming along. Some members have already taken DoC 200 traps to use, after the traps were given to us by PredatorFree Summerhill. There are some still available.

Meanwhile Menzshed is making us the wooden tunnels for our traps which are now going to be D-Rat ones. After seeing these ones demonstrated by the blokes at the Menzshed, who had made 100 of them for Horizons, they are certainly the safest ones to use. The timber is with the Menzshed and the actual traps are on order. So hopefully it will all come together around mid-July and I will be in touch with those of you who have requested a trap.

I attended a meeting of concerned people about the use of herbicides by PNCC ,especially around public parks, playgrounds, schools and so on. It was discussed that it would be useful for signs to be put out indicating that spraying was being done but there was also discussion regarding the need for dead vegetation. There is a trend now to let areas turn wild to do the insects, birds and wild life like lizards, a favour.

## Have you heard of the Rat Virus Project? 🚱

As well as killing our native wildlife, we know that rats can carry diseases that make people and wildlife sick. Overseas, rats are known to carry multiple disease-causing viruses. However, while we know a bit about bacterial diseases that rats carry in Aotearoa New Zealand (such as leptospirosis), we don't know anything about the viruses in New Zealand rats.

Here is where you can help. The project needs wild dead rats of any species, less than one week old since death.

#### SEAWEEK WEBINAR ON THE ROSS SEA

Did you know the Ross Sea is Earth's largest Marine Protected Area? Covering 1.55 million sq km, it is home to a huge diversity of life, it absorbs 90% of excess heat generated by greenhouse gases and is an important carbon sink!

Gain insight into the marine ecosystem of the Antarctic and more in our *upcoming webinar* on July 25 at 7 pm. One of our guests is a Zooplankton Ecologist at NIWA New Zealand. They have travelled to the Ross Sea Marine Protected Area where Dr. Svenja Halfter can conduct research using zooplankton as an indicator of ecosystem changes and the effectiveness of the MPA.

#### **Heat on Fast-track Approvals Bill leads to changes**

The Government is retreating from some of the worst aspects of this contentious Bill. It could have saved a lot of aggravation if Ministers and the Prime Minister had listened to key environmental groups earlier. Then, the reaction to our push-back was aggressively confident. Now, Ministers are indicating there will be substantial changes to the Bill and they have even stopped referring to it by name in the latest Q3 plan.

Whilst EDS sees no need for this legislation (we already have workable fast-track laws in place) if it is to proceed changes need to at least include shifting decision-making to expert panels; widening legal standing to include environmental entities; including sustainable management in the purpose clause; adding environmental matters to the decision-making criteria; removing the override of prohibited activities and water conservation orders; and dropping the proposed scheduled projects altogether.

## Request for list of scheduled project applicants denied

Two months ago, EDS requested the list of applicants that applied for scheduling in the Fast-track Approvals Bill. The Ministry for the Environment has today declined that request. EDS will be making an urgent complaint to the Ombudsman to get that decision overturned. Scheduled projects are proposed to be undemocratically inserted into the Bill. The public has a right to know the potential extent and breadth of environmental damage

the Bill might inflict via scheduled projects.

## **Resource Management (War on Nature) Amendment Bill**

The Government's latest resource management changes miss the mark. EDS has lodged an extensive submission on the (correctly named) *Resource Management (Freshwater & Other Matters) Amendment Bill.* EDS opposes the Bill because it lacks a clear evidence-basis, removes critical protections for freshwater and indigenous biodiversity, and is not consistent with New Zealand's climate change obligations. The Bill also lacks a rigorous cost-benefit analysis, will create legal confusion and increase litigation risk for the Government and councils. We look forward with keen anticipation to our ten minutes before the Primary Production Committee in due course.
